I. Key Market Highlight

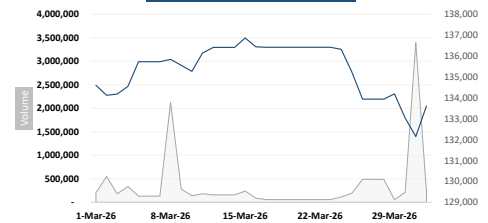
- During Wednesday's session, 163 transactions with an aggregate volume of 223397 shares and a value of SYP 6.46Mln was recorded on the DSE trading platform.
- Overall, during the session, 11 out of the 27 listed stocks recorded market activities, amongst which 2 listed securities witnessed positive share price movements while 1 listed security recorded negative share price movements.
- As for the index, DWX advanced by 1460.84 points (1.11%) compared to the last session to close at 133614.16 points.

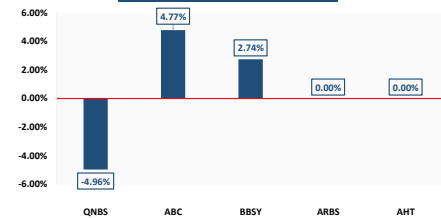
The top five listed securities occupied (illustrated below) 98.73% of the total value recorded during the session:

Top 5 Listed Securities (by Value)

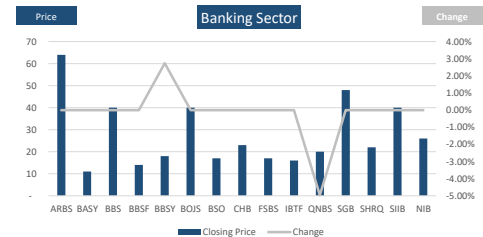


III. Session Summary by Sector

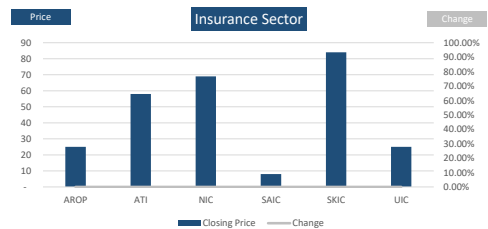
