I. Key Market Highlight

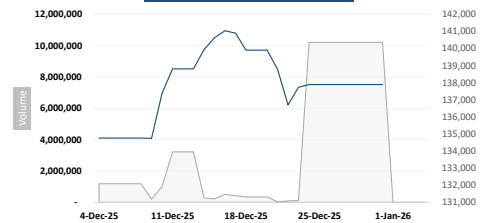
- During Sunday's session, 58 transactions with an aggregate volume of 9911 shares and a value of SYP 1.54Mln was recorded on the DSE trading platform.
- Overall, during the session, 9 out of the 27 listed stocks recorded market activities, amongst which 0 listed securities witnessed positive share price movements while 1 listed security recorded negative share price movements.
- As for the index, DWX declined by -736.81 points (-0.53%) compared to the last session to close at 137151.56 points.

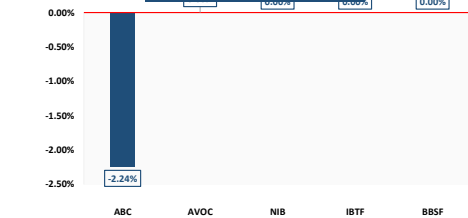

Top 5 Listed Securities (by Value)

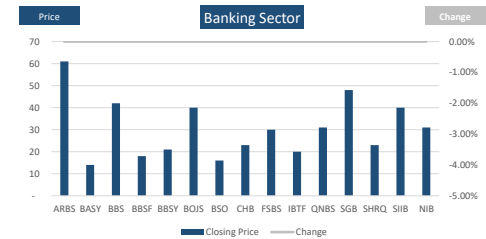


III. Session Summary by Sector

The banking sector index which only accommodates share price changes while weighing all listed bank stocks equally, remains unchanged as the index closing price on the previous day.

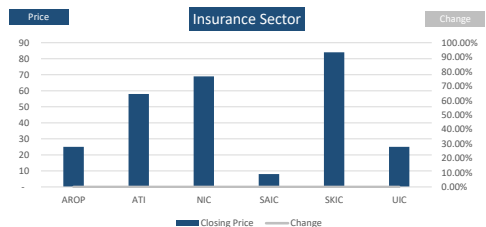
