
**I. Key Market Highlight**

- During Thursday's session, 98 transactions with an aggregate volume of 158788 shares and a value of SYP 3.61Mln was recorded on the DSE trading platform.
- Overall, during the session, 12 out of the 27 listed stocks recorded market activities, amongst which 4 listed securities witnessed positive share price movements while 1 listed security recorded negative share price movements.
- As for the index, DWX advanced by 276.27 points (0.2%) compared to the last session to close at 136419.99 points.


